Abstract—Modernization of fishing gear usually influences the pattern of life of fishermen in various aspects especially ethics and technology used. however, it is different for fishermen in Soreang, Takalar Regency, which in the midst of modernization still maintains ancestral heritage in fishing activities. Spells or seaward rituals are still maintained today. this research aims to; Analyzing the conception of the beliefs of spells or rituals of the Soreang Fishermen community as a guide to making a living at sea in the 4.0 era. This type of research is a phenomenological research with a sociological approach to describe the activities of fishermen making a living at sea while still holding on to ethics, local beliefs that are continuously reproduced as a belief in making a living at sea. The main data collection in this study is field observations and analyzing various documents in the fishing community that are considered relevant to this research. the results showed that, the concept of spell beliefs and rituals was continuously reproduced as a belief capable of surviving and being the driving force of the fishing community in carrying out seagoing activities until the 4.0 era

I. INTRODUCTION

Development is carried out with the aim of making sustainable changes towards better progress [1]–[3]. With the implementation of development carried out, it is necessary to stimulate equitable development and its results in order to improve the welfare of the people, generate initiatives and active role of the community and to increase the utilization of the potential of the region in an optimal and integrated manner in filling real, dynamic, harmonious and responsible regional autonomy, and strengthen the unity and integrity of the Nation [4]–[6].

Local government as a central government apparatus in the development process to realize the welfare of the community in the area [7], [8]. Local governments must be able to accommodate, manage, and empower existing resources as a whole in their respective regions, both natural resources and human resources in the region. Thus one part of the regional development system is the implementation of village development carried out by the village government which is the executor of development in the Indonesian

government in accordance with the implementation of regional autonomy. The success or failure of increasing development in the village is largely determined by the performance of the village head, the village head as the village leader has the role of planning, mobilizing, motivating, directing, communicating, organizing, implementing, in relation to management [9]–[11]. In this regard, the Indonesian people carried out a series of activities carried out in a comprehensive and directed, gradual and gradual plan to stimulate the improvement of national capabilities in the community in order to create a life that is equal to other nations known as national development.

The existence of village officials who are also entrusted with tasks in the field of administration such as collecting, processing and formulating government policy materials, occupies a very important position because as a government organ that knows for certain conditions and problems that exist in its territory, then input to the village government regarding various information and information are needed in making regional and national policies for development needs [12], [13]. Community participation is a process of activities carried out by individuals or groups and the community to unite their interests or links to the organization or community in order to achieve the goals of the community. Participation can be defined as a person's mental / pictorial and emotional / emotional involvement in a group situation that encourages him to contribute to the group in an effort to achieve the goals and responsibilities of the business concerned. Basically village community participation is needed in development [14], [15]. The participation of rural communities in development became the focus of government attention because rural areas are an integral part of the unitary State of the Republic of Indonesia. Participating in rural community development means carrying out the mandate of the ideals of independence and it is the duty of citizens to fill independence. It is also inseparable from the existence of the Village Head as a leader in carrying out his duties as the Village Head basically is a role model and guide and provides motivation for the community.

II. METHOD

This type of research is a qualitative descriptive study. Sugiyono (2014) defines "Descriptive research is research conducted to find out the value of variables without making comparisons, or linking one variable with other variables." The focus of this research is the role of the Village Head as a development administrator as measured through three descriptive descriptions consisting of: 1) Motivator, 2) Facilitator, 3) Mobilizer, while the informants in this study were 3 people namely the village head, village secretary, and community leaders. The data collection techniques used were observation, interviews and documentation techniques. Data analysis techniques used in this study is the interactive model of Miles and Huberman consisting of data reduction, data presentation, and drawing conclusions and testing conclusions [16].

III. RESULTS AND DISCUSSION

Research Results at the Mattirowalie Village Office of Maniangpajo District Wajo District obtained from interviews to reveal the role of the Village Head as Development Administrator are presented based on the definition of the research concept, namely: Motivator, Facilitator, and Mobilizer.

A. Motivator

1) *Motivator*. *Motivator is a motivator, mobilizer or someone who provides motivation in order to achieve the goals that are expected to be achieved in development. The success of the development of a village will be largely determined by the figure of the Village Head as a figure of village government leader. A village head must be able to mobilize human resources by becoming a motivator for the community to achieve the success of the development process starting from planning, implementing, and maintaining the results of development. The role of the Village Head as a motivator in mobilizing community participation is realized in the form of self-help.*

Communication activities undertaken by the Village Head in carrying out his role as a motivator of development and the active role of the community determine the success of development. Based on the results of the interview Mr. Yusbar as Secretary of the Village Mattirowalie explained that: "The village head gives encouragement in the first way financial motivation that is encouragement made by providing financial rewards to employees. These benefits are often called incentives. And the second is non-financial motivation, which is a drive that is realized not in the form of finance or money, but in the form of things like praise, appreciation, human approach and so forth. This opinion is in line with the statement of Mr. Ismail as Calaccu hamlet head of Mattirowalie village explained that: "The encouragement given by the village head by giving praise or appreciation so that it can motivate in village development". This is in line with the statement of Mr. Hermanyah, as community leaders said that: "The village head gives encouragement by way of praise and sometimes also in the form of incentives". Based on this explanation, it can be stated that the role of the village head as a motivator of development has been well implemented so that the community is more motivated in carrying out village development.

2) *Facilitator*. A facilitator is someone who helps a group of people understand a common goal and help make plans to achieve that goal. From this explanation, it can be. It is said by the Village Head that he has a privilege in determining the development of the area such as providing or realizing good services for the community in terms of facilitating or completing the needs needed in the ongoing development process such as designing development and rules that become the signs of community life in the village and funding the implementation is all forms of human activities (community and government), in the village in building oneself, family, social, cultural, political, order, defense and security, religion and government that carry out planned and bring a positive impact on the progress of the village. Thus the village is actually a conscious effort from the community and village government, both by using resources sourced from the village, government assistance and assistance from domestic organizations / institutions.

Based on the statement of Mr. Yusbar, Mattirowalie Village Secretary explained that: "When there are things that are not understood in terms of what is done, the Village Head as a facilitator usually repeats his explanation of the work, so that it can be understood. That happens when there is work being done in question, the mosque construction plan. This is in line with what was said by Mr. Ismail, as the Head of Calaccu Hamlet of Mattirowalie Village explained that: "It is better if the village government officials always repeat the delivery of development programs, so that the community will be easier to remember what was conveyed by the Village Head". A similar explanation was also given by the community, namely Mr. Hermanyah, saying that: it is the duty and responsibility of village government officials to provide an explanation when there are things that are not understood about the problem of the implementation process of development of course is the Village Head. Based on the description it can be said that the Village Head as a facilitator has so far been going well, it seems that the Village Head, in addition to providing facilities to facilitate village development activities, in addition to providing facilities to facilitate development, the Village Head always involves the surrounding community to participate in village government and community programs are also greatly helped by these programs.

3) *Mobilizers*. The role of the Village Head as a mobilizer is a person who directs or moves to do something related to development in the common interest. Regarding the role of the Village Head, in carrying out development in his region is as a development planner, the role of the Village Head is very important in approaching and growing, realizing the implementation of development that has been planned in the village budget. Community participation in the village of Mattirowalie in the development effort can be said to be quite good where there is a heightened public awareness of the importance of cooperation to develop the village. Based on the statement of Mr. Yusbar, Mattirowalie Village Secretary explained that: "before carrying out office work, the Village Head first directs that everything that is done can be carried out carefully so as to achieve the desired goals". In accordance with the statement of Mr. Ismail, the Head of Calaccu Village, Mattirowalie, explained that: "Without the direction of the Village Head, the work will be

difficult to do, therefore the Village Head always gives direction". Based on the results of the study it was found that, the government really paid great attention to the village in improving the welfare of the community, so the role of the Village Head as a mobilizer or mobilizer was enough to provide awareness that the importance of cooperation in the development process could later be enjoyed together

B. Discussion

The role of the village head as a development administrator in the village of Mattirowalie sub-district is known that the village head acts as a motivator for village officials and their citizens. The position of the village head is quite a role as a facilitator for its citizens, and a role as a mobilizer for its citizens.

1) *Motivators.* The importance of the role of motivator in the village development process and needs to be understood by the village government in this case is the Village Head in Mattirowalie Village in order to take various forms of action or assistance to the local village community. The village head as a motivator must be able to motivate citizens to be active as well as in the implementation of development so that the development to be achieved will be carried out properly without disputes between the village government and the local community, as the Village Head must be able to provide encouragement to the active community in community activities so that later achieve certain goals in order to meet or satisfy a village community's needs in improving village development. As the Village Head, in this case as a motivator, has worked together with the community in this matter, namely jointly in improving village development by providing encouragement to residents, here it can be seen that the encouragement of the Village Head is always carried out with the aim that it gives awareness to the village community, especially Mattirowalie Village, about the importance of cooperation in a development process. In addition, with this certainly received a positive response from the people of the village of Mattirowalie because the encouragement and guidance from the Village Head is very much needed and awaited by the village community. This can be seen that the role of the Village Head as a motivator has provided motivation or encouragement to villagers to participate in village development activities.

2) *Facilitator.* The role of the Village Head as a facilitator, that the Village Head performs his role as a facilitator in terms of facilitating or completing the needs, facilities and infrastructure that supports the process of government and village development. The facilitator can also be said as a facility performer, which is helping to manage an information exchange process, smooth communication, and problem solving together. The facilitator is not the person in charge who only provides training, advice or opinions. The facilitator must be a good resource for various problems. The village head as a village facilitator is a community assistant in the implementation and enhancement of village development programs, meaning that a facilitator must be able to provide and be ready with information including occupation. The role of the

Village Head as a facilitator is enough to help the people of Mattirowalie Village, this is evident from the results of interviews with three informants who stated that the Village Head was very helpful in solving the problem of village development.

3) *Mobilizer.* Regarding the role of the Village Head, in carrying out development in his region is as development planning, the Village Head as a mobilizer, development supervisor, pioneer of development, and the role of the Village Head is very important in approaching and growing and developing community self-help to realize the implementation of development. planned in the village budget (APBD). This means that the Village Head as the leader in the village is the organizer and person in charge of the government, development and community midwives, also the Village Head is responsible for growing and developing community self-help. Moving the community in the development of development is very important for the village government, where the Village Head Mattirowalie always invites the village apparatus to mobilize the community and participate in the implementation of physical and other development, as well as providing guidance to the community to do something that is useful for the benefit of many people, as well as other interests to long-term. The village head of Mattirowalie stated that the implementation of development was inseparable from various problems, it could be solved together so.

IV. CONCLUSION

Based on the discussion of the results of this study, it was concluded that the role of the Village Head as the Development Administrator has run well, as the village government has carried out its role as a motivator, facilitator, and mobilizer in accordance with the duties, authorities and functions as a village development administrator.
