Influencers are compensated by companies who ask them to advertise and describe a good or service via social media content associated with their line of work. The goal is to influence viewers and supporters to take out their wallets and buy the product. Influencers have the opportunity to grow both personally and professionally. However, it must be made clear to whom these benefits belong and who should have the power to determine whether a child should play the role when it comes to child influencers. The child is voluntarily acting in their capacity as a child influencer or.

More specific arrangements must be made in relation to the development of talents and interests, per the Minister of Manpower's Decree No. KEP.115/MEN/VII/2004 on the Protection of Children Engaged in Work to Develop Talents and Interests. A child is permitted to work under the terms of the decree as long as they can pursue their interests and talents and the following requirements are met:

- 1. Children typically start doing the work at a young age.
- 2. The work is of interest to children
- 3. Children are interested in the work.
- 4. The project encourages creativity and fits into the world of the kid.

These requirements stipulate that the child's work must be in his or her best interests. The child shouldn't be required to do the job at all, let alone have to have a skill or perform an activity that is unusual for young children. However, no one has the right to make a child work against their will, and if it is, it must be done in a way that fosters their creative growth and development within the confines of their natural environment.

According to the Ministerial Decree, a child's interests and skill development must come first when they are involved in a profession. This can be accomplished using the subsequent techniques:

- 1. Children are respected and heard
- 2. In treating children, care is taken to ensure their complete physical, mental, intellectual, and social development.
- 3. Children are still educated, treated equally, and free from coercion.

It is basically forbidden for work that a child is assigned to restrict any of his or her inalienable rights, including the chance to grow and learn. Children who work must still have the chance to mature and flourish in the same ways as other kids. The employment should be suspected of being exploitative if it results in a child losing these opportunities and does not prioritize the child's best interests.

The definition of exploitation is the act of using something unfairly or maliciously for one's own gain. In more detail, Article 66 of Law No. 35 of 2014 on the Amendment to Law No. 23 of 2002 on Child Protection (Child Protection Law) defines economic exploitation of children as "actions with or without the consent of the child who is a victim, which includes but is not limited to prostitution, forced labor or service, slavery or practices that are similar to slavery, oppression, extortion, physical, sexual, reproductive or-gan utilizat-ion, and other forms of exploitation." In the event that

Every child in the custody of parents, guardians, or other parties responsible for their care has a right to protection from economic and social exploitation, as stated in Article 13 of Law No. 23/2002 on Child Protection. Parents, guardians, and caregivers should receive harsh punishment if they violate these rules, according to the second paragraph.

The Child Protection Law, which establishes roles for local governments and other state institutions, including the Indonesian Child Protection Commission, an independent national commission established by the government and in charge of child protection in Indonesia, outlines the obligation and responsibility to provide particular protection for economically exploited children. These particular safeguards are in question:

- 1. Early intervention, medical, psychological, and social care rehabilitation, as well as disease and other health problem prevention
- 2. During treatment and recovery, assistance with psychological needs is provided
- 3. Giving social assistance to kids from low-income families
- 4. supplying defense and support throughout every legal procedure.

Child influencer work can be categorized as the worst type of child labor if it is determined to be coercive and/or furthermore poses a threat to the health and safety of the child being employed. This is in line with the concerns expressed regarding previous regulations. that when acting in the capacity of a child influencer, it is essential to be knowledgeable of the circumstances that constitute child labor or other types of exploitation.

Parents or guardians, along with the federal, state, and organizations like the Child Protection Commission, are a major part of enforcing these boundaries. Parents should be the ones with the most knowledge about their children's interests and talents in addition to having a duty to protect children's rights from interference with their development as people. Ironically, though, they also stand to benefit the most from child influencers' efforts. It's actually common for the child's parents to serve as the point of contact and decide how much of their child's work is directed in each direction as a child influencer.
