

Framing Sexual Misconduct Claims: A Case Study of Online News Coverage in Indonesia

Abstract. This study aims to determine and describe how the framing of the news of the alleged sexual harassment of Gofar Hilman on the online media Kompas.com for the period June 2021 and February 2022. Researchers chose the June 2021 and February 2022 periods because the news during this period of the news of Gofar Hilman's alleged sexual harassment became a conversation in every information media regarding the alleged sexual harassment case which was still confusing about the truth. This research uses a qualitative method with a descriptive approach. And using Robert N. Entman's framing analysis method through his four elements, namely: problem identification, identification of the cause of the problem, moral evaluation, and finally problem solving suggestions. The results of this study show that problem identification framed by Kompas.com online media is more focused on the development of sexual harassment problems committed by Gofar Hilman until the decision of the authorities. The second element of causal interpretation framed on Kompas.com online media is Syerin who was in the spotlight when she made a thread on her Twitter account about sexual harassment experienced in 2018. In the third element of moral evaluation framed by Kompas.com, the owner of the @quweenjojo account turned out to have made false accusations of sexual harassment committed by Gofar Hilman, and the fourth element of treatment recommendation framed by Kompas.com is to resolve the case of alleged sexual harassment committed by Gofar Hilman by means of mediation conducted by Gofar Hilman and Syerin and her parents and accompanied by the police.

Keywords: framing analysis, gofar hilman, kompas.com.

1 Introduction

Technological developments can make it easier for people to keep up with the times and obtain information effectively and efficiently. Mass media has the aim of delivering correct, efficient and effective information to every audience. The superiority of mass media lies in its ability to disseminate information cheaply, quickly, standardized and accurate. [1]. Online media is mass media that we can find on the internet, online media can also be called online. Online news is simply defined as media that "reports facts or events that are generated and disseminated via the internet".[2] . The rapid development of media can be positive or negative. The speed of dissemination, and being able to be known quickly by the public anytime and anywhere are its advantages.

The Ministry of Education and Culture's website states that in 2021, from January to October, the National Commission on Violence Against Women received complaints about 4,500 cases of sexual harassment, which is a very high number compared to previous years. [3]. The emergency of

sexual violence that occurs every year is getting more extreme, but it is precisely the failure to handle cases that occur that makes victims feel even more battered, helpless, and a loss of security.

Victims of sexual violence are very vulnerable to suffering physically, and psychologically, generally these victims will experience *Post Traumatic Stress Disorder* (PTSD) and provide excessive anxiety and lead to self-harm to suicide. What is really needed by victims of sexual harassment is moral and legal protection, from a legal point of view the TPKS Bill is a legal instrument that will become an umbrella of protection for victims to get justice [5]. [5]. Although in reality, the draft law has not yet been finalized and has experienced various pros and cons.[6]

From this phenomenon, this research raises a news case in the online media kompas.com regarding the news of the Gofar Hilman sexual harassment case which occurred on June 8, 2021. Researchers chose this case because when this case emerged, this case went viral and became a big spotlight on victims of sexual harassment committed by Gofar Hilman to get trending hastags on Twitter social media when the case emerged. When the case emerged kompas.com reported a total of 12 news stories about Gofar Hilman's sexual harassment case from June 9, 2021 to February 13, 2022. Researchers chose the news source kompas.com because when the case of sexual harassment committed by Gofar Hilman appeared, kompas.com reported more than other news portals when compared to the tribun.com news portal which only reported the Gofar Hilman case as much as 8 news. Kompas.com is a web portal that contains online news and articles, Kompas.com only has an online edition and relies on advertising revenue. Established in 1995, Kompas.com is part of Kompas Gramedia. [7].

Gofar Hilman was an announcer for Hard Rock FM Radio from 2012 to 2021. Apart from being a broadcaster Gofar Hilman is also a creator on YouTube or people often refer to him as a Youtuber, Gofar has various content on his YouTube channel such as Ngobam (Ngobrol Bareng Musisi) and automotive content called Sekut Otomotif, and Gofar Hilman is one of the CEOs of Lawless Jakarta. The beginning of the case of alleged sexual harassment committed by Gofar Hilman surfaced on social media Twitter on June 8, 2021 when the victim's Twitter account @quweenjojo told that he had been sexually harassed by Gofar Hilman in 2018 at a coffee shop in Malang. [9]. Syerin, the real name of the account owner @quweenjojo, recounted the incident when he attended an event held at the coffee shop "Rumah Opa" and Gofar Hilman was a guest star at the event, at the event Syerin wanted to intend to ask for an Instastory with Gofar. The day after, the tweet thread was discussed. @quweenjojo recounted on his Twitter account the chronology of events he experienced in 2018, @quweenjojo made a "Thread" on his Twitter account telling the story of the sexual harassment he experienced. A few hours after posting the "Thread" on his Twitter account, it received tens of thousands of Retweets by twitter users. Gofar Hilman as the youngest clarified and denied having committed sexual harassment in the 2018 incident. "For the issue of allegations of harassment, here I am sure I did not do that, there were two people who accompanied me at that time, 1 committee girl and 1 guy my assistant, they took care of me until I got into the car at the end of the event," wrote Gofar on June 8, 2021 via the @pergijauh account. In fact, at that time Gofar wanted to take the matter to the realm of law, alleging that there was an element of slander in the confession of the @quweenjojo account.

Of all the articles published by kompas.com regarding the news of sexual harassment committed by Gofar Hilman, kompas.com media covered the entire development process that occurred in this case. The beginning when Quweenjojo made a post on her twitter accusing Gofar Hilman of having sexually harassed her, reported to LBH APIK Jakarta, then reported a version of the confession from Gofar Hilman who was very sure that he had not committed the act in 2018, and until reporting on the development of the case which turned out to be Quweenjojo or a woman whose real name is Hafsyarina Sufa Rebowo who has the nickname Syerin admitted to having made false writings about

the story made on her twitter social media account regarding the experience of sexual harassment committed by Gofar Hilman. and finally Syerin apologized to Gofar Hilman and withdrew the report from LBH APIK and the case ended peacefully for both parties.

This is in line with research conducted by Oktafira, which both discuss news or a series of events presented by Kompas in a coherent manner. Which has the title "Robert N.Entman's Framing Analysis on the News of the #2019gantipresiden Campaign at Kompas.Com" by analyzing six news stories that match the topic. And got the result that the Kompas.com media portal framed the news with social construction according to the public interest, news protrusion is also neutral. This is evident in the news written about the #2019GantiPresident campaign including the impact that will occur for Indonesian unity during the election. [10].

Certain dramatic and immortalized events have an influence on how people perceive an event. Images of people, groups, even realities are always adjusted to the icons that are already embedded in the minds of the public. The icons created in the news limit the audience's view, as if it is a perfect portrait in describing certain people, events or groups. Because it is portrayed perfectly and dramatically, when there is a similar event, it is always passed down from one generation to the next with the same perspective. [11].

The effects of framing formed by online media are very diverse, such as the reality of existing news is not captured and written in accordance with the facts, but the opposite reality, namely disconstruction. Online media framing news can also obscure other aspects of the news, ignore other effects, present a certain side, or can lead the audience to certain memories. In this study, researchers used framing analysis to see how media portals or journalists in the media select certain issues to be written and aired as news. Framing analysis is a method to analyze how reality (events, actors, groups, or anything) is framed by the media through a reconstruction process. [12]. Framing analysis can see how reality and events are constructed by the media.

With the emergence of the alleged harassment case committed by Gofar Hilman, a lot of mass media reported about it. In this case Kompas.com acts as one of the mass media that covers events related to the entire chronology of the alleged sexual harassment case from various sides. Kompas.com covered the events that emerged about the news of sexual harassment involving Gofar Hilman. Therefore, researchers chose Kompas.com as one of the credible media regarding the news of the alleged sexual harassment committed by Gofar Hilman where the case caused a lot of wild opinions, opposition, and had a wide impact.

1.1 Framing Analysis

Framing is a way of understanding how journalists use a perspective or perspective when selecting issues. This point of view or opinion ultimately determines which facts are adopted, which parts are emphasized and omitted, and where the news is taken. Entman divides the framework into two main dimensions, namely: problem selection and emphasize or highlight aspects of reality. These two factors can further sharpen news framing through the process of selecting issues that are worthy of being displayed and emphasized in the news content. [13] The reporter's perspective will determine the facts he chooses, emphasizes, and discards. Behind all that, the decision of which side to highlight certainly involves the values and ideologies of journalists involved in the news production process. As mentioned earlier, highlighting is the process of making information more meaningful. Of course, a prominent or prominently presented reality has a high chance of being noticed and influencing the audience's understanding of reality. Thus, in practice, media framing is done by selecting certain issues and ignoring others; and by using various discourse strategies to highlight aspects of these issues - prominence (in headlines, front or back), repetition, use of graphics

to support and enhance the prominence of the use of certain labels when describing people or events to be reported.

Based on the exposure to the background of the problems described above, the author takes the title Robert Entman Framing Analysis of the Gofar Hilman sexual harassment case on Kompas.com for the July 2021 and February 2022 periods as the research that the author will conduct. The author chooses to use framing analysis, which can simply be described as an analysis to find out how reality (events, actors, groups, or anything) is framed by the media. In framing analysis, what we do is see how the media constructs reality. Events are understood not to be something that is taken for granted; rather, journalists and the media actively shape reality. [13]

1.2 Framing Technique According to Robert N. Entman

Framing in the news is done in four ways, namely: first on problem identification (problem identification), second is the identification of the cause of the problem (causal interpretation), third, on moral evaluation (moral evaluation), and fourth treatment recommendation (treatment recommendation).[14]

Entman sees framing as having two main dimensions, namely: selecting issues and emphasizing or accentuating some aspects of reality or issues. Highlighting is the process of making information more meaningful, interesting, meaningful, or more memorable to the audience. [15][16]. Realities that stand out or are presented prominently are more likely to be noticed and influence viewers' understanding of reality. In practice, the media highlight aspects of the issue by selecting certain issues and ignoring others and by using various discourse strategies, repetition, the use of graphics to support and reinforce salience, the use of certain labels when describing people or events, the outer frame of the report, association with cultural symbols, generalization, simplification, etc. [17] In Entman's concept, framing basically focuses on providing definitions, explanations, evaluations and recommendations in a discourse to emphasize a certain frame of mind towards the event being discussed. [18].

Researchers chose the Robert N. Entman model because it is more suitable for analyzing the news coverage of the Gofar Hilman case in the online media kompas.com. This is because the model can explain how a reporter chooses an issue or event and highlights the salient parts of the news.

2 Research Methods

The type of research used in this research is a qualitative method with a descriptive approach. Qualitative research has the aim of obtaining in-depth data, the intended data is to obtain true meaning. So in qualitative research it is used to examine natural objects which will produce data that is more about meaning than generalization. [19]. With a descriptive-qualitative approach to analyzing the news framing of the Gofar Hilman case on kompas.com online media, researchers will observe and describe how kompas.com online media frames a case and researchers will explore it in depth.

The subject of this research is Gofar Hilman as a suspect in a sexual harassment case. Meanwhile, the object of this research is the kompas.com online media portal which is the data source used by researchers. The data sources in this study took several news articles on the kompas.com news media portal which contained cases of alleged sexual harassment committed by Gofar Hilman in the June 2021 and February 2022 periods. This research uses the documentation observation method on the news published by Kompas.com regarding the news of the alleged sexual harassment committed by Gofar Hilman. The data collected by researchers are in the form of 5 (five) news articles that discuss the news of the alleged harassment by Gofar Hilman. And also other data obtained from books, scientific journals, scientific articles, mass media and the like related to the research topic. The data analysis technique used is using Robert N. Entman's framing analysis data analysis technique. Which means that the data that has been collected will be arranged, grouped and organized then analyzed based on the elements contained in Robert N. Entman's model.

Framing in news is done in four ways, namely: 1. Problem definition - How is an event/issue seen? As what? Or as what problem? 2. Estimating the problem or source of the problem - What is the event seen as caused by? What is considered the cause of a problem? Who (actors) are perceived as the cause of the problem? 3. Making moral decisions - What moral values are presented to explain the problem? What moral values are used to legitimize or delegitimize an action? 4. Emphasizing solutions - What solutions are offered to overcome the problem/issue? What path should be taken to overcome the problem? [20] The primary data of the research is the news about the sexual harassment committed by Gofrar Hilman in the online media kompas.com in the period June 2021 and February 2022. The secondary data of the research relates to various literatures that can be used as references in the process of analyzing the news from both the media and the reality under study.

3 Results and Discussion

In this study the authors analyzed the news on kompas.com online media with the following details:

3.1 News Framing Analysis 1

Headline "Chronology and 7 Messages from Nyelaras, the Alleged Victim of Gofar Hilman's Harassment" on kompas.com. Gofar Hilman related to alleged sexual harassment by a woman who told her experience of being harassed by Gofar in 2018. The news chaining above shows how kompas.com focuses on what Syerin wrote on her twitter account, it can be seen from the title chosen by kompas.com and the content of the news that focuses on what Syerin told, The framing analysis of kompas.com's news is as follows:

Problem identification, from the first news, Gofar Hilman is suspected of harassing one of the women in 2018, this case was revealed when the victim told on her twitter social media, namely \@quweenjojo or Syerin on June 8, 2021.

Causal interpretation, identifying the cause of the problem in the news above is Gofar Hilman who has committed an act of sexual harassment against one of the visitors to an event in 2018, kompas.com quotes from the writing shared on the victim's twitter @quweenjojo as follows: "After finishing recording a video with him, his hand suddenly hugged me from behind. I started to get confused about what to do because the hug was really tight? I was wearing a knee-length dress, Gofar's hand suddenly entered my shirt. One hand from above, the other from below. I was in shock," Nyelaras wrote. [21]

Moral evaluation, making moral decisions in the first news, kompas.com quotes from @quweenjojo or Syerin's tweets addressed to Gofar Hilman and all people who read his tweets, which are as follows: 1. Gofar to realize what he did 3 years ago and not repeat it to anyone, 2. Reminding Gofar that not everyone wants to do anything with you. 3. Reminding everyone to be careful in taking actions, even in public spaces. 4. Reminding everyone that being harassed in public is never a good thing. 5. Helping people who are harassed anywhere is everyone's responsibility. 6. Don't take harassment lightly, not everyone can handle trauma well. 7. So that everyone who intends to harass anyone can think many times about the consequences of their impulsive and disgusting actions. [21]

After seeing the writing made by Syerin, Gofar Hilman immediately denied the allegations and wanted to contact Syerin who had written the writing on his twitter. "For the issue of allegations of harassment, here I am sure I did not do that, there were two people who accompanied me at that time, 1 committee girl and 1 guy my assistant, they took care of me until I got into the car at the end of the event," Gofar is also ready to resolve this confusing case with a legal process or through other proposals to discuss input with Syerin.[21]

After going through the four elements of analysis on the news above, it can be concluded that kompas.com constructs more on the writings that have been published on twitter @quweenjojo as the entire content of the news, from the initial chronology of Syerin writing the events that have been experienced in 2018 ago to the response from Gofar about the case that dragged his name.

3.2 Framing analysis of news 2

Headline "Gofar Hilman's Clarification on Sexual Harassment Allegations" on kompas.com. Gofar clarified that he was very sure that he did not commit sexual harassment against one of the visitors at the event in Malang in 2018. Gofar and his team are trying to contact the owner of the

@quweenjojo account to solve the problem that occurred The framing analysis of the kompas.com news is as follows:

Problem identification, from this second news report contains clarification from Gofar Hilman regarding the alleged sexual harassment case he committed. In the news presented, Kompas.com quoted Gofar Hilman's clarification written on his Twitter account. The quote is "For the issue of allegations of harassment, here I am sure I did not do that, there were two people who accompanied me at that time, I committee girl and I guy my assistant, they took care of me until I got into the car at the end of the event," continued Gofar Hilman."[22]

Causal interpretation, identification of the cause of the problem in the news above is Kompas.com reporting on Gofar Hilman's clarification of alleged sexual harassment to one of the visitors at an event in Malang in 2018. Gofar and his team are trying to contact the account owner @quweenjojo to resolve this issue and hope that this problem can be resolved as soon as possible.

Moral evaluation, the moral judgment contained in the news is that Gofar Hilman apologized to all parties who were uncomfortable when he embraced, Gofar apologized for this because he did not ask permission for the embrace. The news wrote an apology delivered by Gofar "I really remember that event, at the event many guys and girls asked for Instastory, here I apologize to all parties who were uncomfortable when I embraced, it was my fault for not asking for consent for the embrace,".[22] So the conclusion teaches us not to do anything without permission because not everyone can accept what we do.

Threatment recommendation, a suggestion for overcoming problems in this problem, namely Kompas.com quoting a tweet on Gofar Hilman's Twitter social media account, is willing to resolve this problem as soon as possible, Gofar denied that he had committed the harassment in the 2018 incident.

After going through the four elements of analysis on the news above, it can be concluded that kompas.com constructs more to Gofar Hilman who explains or clarifies about the case that dragged his name on twitter. It can also be seen from the title to the content of the news that focuses more on Gofar Hilman's clarification.

3.3 Framing analysis of news 3

Headline "Confide in the Development of the Case, Gofar Hilman: No Response at All" on kompas.com. Gofar Hilman is waiting for an answer to the efforts made to the owner of the Twitter account @quweenjojo, one month has passed Gofar's good faith in trying to communicate with @quweenjojo has not yet found a bright spot. The framing analysis of kompas.com news is as follows:

Problem identification, after the writing made by Syerin on his twitter, the account owner disappeared and could not be contacted by Gofar to mediate to resolve this issue. This can be seen in the news text as follows: "After waiting without news, my team tried to contact the relevant parties again, but he said that all further contact would be through the attorney from his side," wrote Gofar.[23]

Causal interpretation, the writing made by Syerin on her twitter social media on June 8 received a lot of response from the twitter audience and became a trending topic #Gofar After telling the thread Gofar responded to what was written by Nyelaras, @quweenjojo claimed to be collecting evidence on the incident and collecting several witnesses to later be taken to legal channels.

Moral evaluation, Gofar and his team regretted that there was no good response from the victim @quweenjojo regarding the progress of the case against him. Gofar has sent a letter to @quweenjojo twice but the goodwill was not responded to by Nyelaras and her companion.

Threatment recommendation, advice on overcoming problems in this problem, namely, Gofar Hilman has given two invitation letters to meet with the victim @quweenjojo but the letter was not responded to by the victim and the companion. After waiting for one month without any response from the victim, Gofar did not hesitate to take firm steps to get a bright spot. "The losses I have experienced are not only material but also mental. Therefore, next I will take more decisive steps so that this incident can reach a bright spot and find the truth," he wrote ending his thread on Twitter.

"Narratives that are not clear about the truth are coming in a lot. I have been convicted in the social sphere without going through the proper process," he continued.[23]

After going through the four elements of analysis on the news above, it can be concluded that kompas.com constructs the news above to show that Gofar is waiting for the continuation of the case that dragged his name, because after the victim wrote about being harassed by Gofar in 2018, the victim immediately did not provide a continuation of this case, while Gofar has suffered material and physical losses because of the case that dragged his name.

3.4 Framing analysis of news 4

The news title "Now Denying Being Harassed by Gofar Hilman, Quweenjojo Mentioned Only Being Embraced" on kompas.com. After a long disappearance, the owner of the Twitter account @quweenjojo told what really happened on the incident on August 19, 2018. Hafsyarina Sufa Rebowo, the real name of @quweenjojo, uploaded a video on Twitter about what really happened on February 11, 2022. The framing analysis of the kompas.com news is as follows:

Problem identification, the owner of the Twitter account @quweenjojo or Syerin's real name, Syerin told the truth in his Twitter thread written on June 8, 2021 is fake and cannot be accounted for.

Causal interpretation, after a long time disappearing Syerin reappeared on his twitter account, Syerin reappeared and uploaded a clarification video as well as an apology to Gofar Hilman and the twitter audience who had supported and supported the move for having the courage to speak up about the bitter experience of 2018 ago. explained that the incident that actually happened was that Syerin was only embraced nothing more "At that time I also drank alcohol or drunk, also there I met Gofar Hilman and intended to take a selfie video. And was greeted by Gofar and embraced, just embraced," Syerin said. [24]

Moral evaluation, Syerin exaggerated about the thread she made on June 8 which resulted in Gofar Hilman's side getting a huge loss. Syerin explained that there was a delusional or imaginative urge to tell the public about it.

Treatment Recommendation, Syerin said that on August 19, 2018 she was under the influence of alcohol and the harassment written on her *thread* did not happen. When she finished making the fake *thread* on her Twitter account, Syerin admitted that she was nervous after making the *thread* and wanted to apologize to Gofar Hilman because she had already written it.

After going through the four elements of analysis on the news above, it can be concluded that kompas.com constructed the fourth news showing the appearance of Syerin after a long time disappearing, the beginning of Syerin being discussed by the twitter audience, namely regarding the writing made about the bitter experience that had received sexual harassment treatment by Gofar in 2018.

3.5 Framing analysis of news 5

Headline "Chronology of Gofar Hilman's Alleged Sexual Harassment Case that Led to Quweenjojo's Apology" on kompas.com After a long time ago, on February 11, 2022, @quweenjojo

or Syerin reappeared and made an apology for the *thread* that was created on June 8, 2021. Syerin apologized for creating a fake *thread* and could not be held accountable for the truth, Syerin stated that he did not receive sexual harassment by Gofar Hilman. The framing analysis of the kompas.com news is as follows:

Problem identification, Quweenjojo or Syerin apologized to Gofar Hilman about his alleged sexual harassment in August 2018 and confirmed that the *thread* created on the @quweenjojo Twitter account was fake and could not be accounted for. [25] The impact of the article published on June 8, 2021 resulted in Gofar Hilman also being expelled from Lawless Jakarta, Gofar himself became one of the founders of the Lawless company and received attacks from the twitter audience until it became a *trending topic* #Gofar

Causal interpretation, nine months later @quweenjojo or Syerin again uploaded a clarification video about the *thread* he made in June 2021 which is a fake *thread* and cannot be accounted for.

Moral evaluation, Syerin said that during the incident in August 2018 Gofar Hilman only embraced when Syerin asked for an *instastory*. Syerin apologized to Gofar Hilman for the false accusations that had been told on her Twitter account and caused assumptions that were detrimental to Gofar Hilman.

Treatment Recommendation, Gofar Hilman felt relieved after successfully meeting with the owner of the Twitter account @quweenjojo, in the mediation Gofar met with Syerin and conveyed the real chronology of events, and the mediation process went well and Gofar had forgiven Syerin. After the mediation process was completed and Gofar Hilman had forgiven Syerin for the alleged sexual harassment case. LBH Apik sent out a press release. When confrimed by Kompas.com, the release said, LBH Apik confirmed that there was one of the reporters who revoked her report against Gofar Hilman for sexual harassment. The revocation was made on February 10, 2022 right after Gofar Hilman and Syerin conducted mediation. [25]

The researcher concluded that Kompas.com oversees the case of alleged sexual harassment committed by Gofar Hilman, presenting news with the facts as they occur, every development of this case, Kompas.com does not provide personal opinions on this case and does not corner one of the parties to this incident.

4 Conclusion

Kompas.com online media in framing the news of the alleged sexual harassment case committed by Gofar Hilman focuses on both parties to resolve this problem, Kompas.com conveys this case with facts that occur in the field. After analyzing the data regarding the Gofar Hilman sexual harassment case on Kompas.com online media. The news presented by Kompas.com online media about the alleged harassment committed by Gofar Hilman tends to be neutral and does not take sides with the two parties concerned, namely Gofar and Syerin as victims of the alleged harassment. This is evident from the news written by Kompas.com which is presented in accordance with the development of te conflict, starting from the emergence of the problem until the end of the problem is resolved. Kompas.com also when reporting on the alleged sexual harassment case of Gofar Hilman from the news that the author chose did not only frame Gofar as the alleged perpetrator. In the news written, there are always quotes from the statements of the two parties when conducting a press conference or clarification on Twitter. Kompas.com also makes headlines that do not corner either party. In other words, Kompas.com online media carries out social construction with the public interest, and is neutral, it can be seen from the 5 news articles that the author chooses, the selection of titles and news content published by Kompas does not corner one of the parties.

Kompas.com covers this case more completely with other online media, Kompas.com covers the case of alleged sexual harassment committed by Gofar Hilman because Gofar is a public figure who is quite influential for young people, works at the capital's radio station in prime time hours and sexual harassment cases are a very concerned issue for young people today.
