All of the articles in this proceedings volume have been presented at the 6<sup>th</sup> Open Society Conference 2024 in 26 September 2023 in South Tangerang, Banten, Indonesia. These articles have been peer reviewed by reviewers, the members of the Scientific Committee and approved by the Editor-in-Chief, who affirms that this document is a truthful description of the conference's review process.

#### 1 REVIEW PROCEDURE

The reviews were double-blind review. Each submission was examined by editor and 1 reviewer independently. The conference submission management system was OJS 3.3.0.11.

The submissions were first screened for generic quality and suitableness by editor (desk review). After the initial screening, they were sent for peer review by matching each paper's topic with the reviewers' expertise, taking into account any competing interests. A paper could only be considered for acceptance if it had received favourable recommendations from the two reviewers.

Authors of a rejected submission were given the opportunity to revise and resubmit after addressing the reviewers' comments. The acceptance or rejection of a revised manuscript was final. Committee, editorial, and reviewers are recused from the handling of papers by closely related authors to reducing the bias or subjectivity in publishing articles.

# 2 QUALITY CRITERIA

Reviewers were instructed to assess the quality of submissions solely based on the academic merit of their content along the following:

- 1. Pertinence of the article's content to the scope and themes of the conference;
- 2. Clear demonstration of originality, novelty, and timeliness of the research;
- 3. Adherence to the ethical standards and codes of conduct relevant to the research field;
- 4. Soundness of the methods, analyses, and results;

- 5. Clarity, cohesion, and accuracy in language and other modes of expression, including figures and tables.

In addition, all of the articles have been checked for textual overlap in an effort to detect possible signs of plagiarism by the publisher.
